Criteria for the evaluation of research activities at FIM UHK in 2019

1) An article in a professional periodical (Document Type: Article or Review) contained in Thomson Reuters's Web of Science database and published in a periodical whose impact factor is published annually in the



- Thomson Reuters Journal Citation Report (JCR); Q stands for the quartile, i.e. the quarter in which the journal is ranked in the JCR journals (it is 1, 2, 3, or 4). If the magazine is in more than one field, this is an average value.
- 2) An article in a professional periodical (Document Type: Article or Review). The journal must be included in the Emerging Sources Citation Index (ESCI) registered with the Web of Science Core Collection.
- 3) An article in a professional periodical (Document Type: Article or Review), which is included in the SCOPUS database and has a non-zero SJR index; q stands for the quartile, i.e., the quarter in which the journal is ranked in the order of journals of the given SJR field (it is 1, 2, 3, or 4). If the journal is in more than one field, this is the average point value for the quartiles see point 6). (http://www.scimagojr.com/journalrank.php)
- 4) Non-periodical professional publication of at least 100 standard pages (i.e., 50 printed pages) of text published by the press and reviewed by at least one generally recognized reviewer in the relevant field. The formal attributes of a monograph are references to literature in the text, a list of used literature, a summary in at least one world language, possibly a list of explanations, and a bibliography of sources. The book is assigned an ISBN or ISMN and a required copy is registered in the National Library of the Czech Republic. The whole book is created by a team of authors (no matter how the individual members of the team share the content), even if the individual chapters of the book have separate authorship. These monographs are not teaching materials (textbooks), expert reviews and opinions, translations, yearbooks and annual or similar periodic reports, statistical yearbooks, unpublished diploma, doctoral and habilitation theses, language dictionaries, print or electronically published search summary, summaries of professional papers (e.g., within one workplace), proceedings, etc.
- 5) The point value is calculated from the point value of the relevant monograph multiplied by the chapter factor. The chapter factor is determined as the ratio of the number of pages of the chapter to the number of pages of the whole book. In cases where the number of pages of a chapter or book is not specified, the chapter factor is 1/10.
- 6) The proceedings must be registered in the SCOPUS database or the Conference Proceedings Citation Index Science or Social Science & Humanities (formerly ISI Proceedings) of Thomson Reuters as a Proceedings Paper, Conference Paper or Conference Review with ISBN, possibly with ISBN as well as ISSN. (If it is assigned a non-zero SJR index value in the SCOPUS database, the point value is assigned by the quartile so that for q = 60, q = 30, q = 10, and q = 4, the quartile is available at http://www.scimagojr.com/journalsearch.php, or equivalent quartile for journals in a given field. If the conference is in more than one field, this is the average point value for the given quartile. In other cases (no SJR index) D = 4) Ex.: If the proceedings are, for example, in three fields and their quartiles are q = 4, q = 4 and q = 4, the result is q = 4, and in such cases, the maximum number of points defined in L1 does not apply, as it is not just q = 4 scope(s).
- 7) Only such technical solutions that are registered by the Industrial Property Office in the register of patents/ utility models can be considered as a patent/utility model.
- 8) An industrial design is a result that enjoys protection under Act No. 207/2000 Coll., on the protection of industrial designs and on amendment to Act No. 527/1990 Coll.
- 9) A more complex industrial product, designed to verify the design features and whose development was the aim of the project of applied research, experimental development and innovation or other activities of applied R&D&I.
- 10) Software demonstrably created in connection with the solution of the research activity, which can be freely used in accordance with the license conditions of the creator and in accordance with § 16 of Act No. 130/2002 Coll. It is not software that was created solely for the purpose of UHK.
- 11) Methodology approved by the competent authority of the state administration and recommended for use in practice.
- AV1) The category of applied results will be assessed comprehensively for one total applied result (i.e. for the result when it is applied as a functional sample and the software will be considered as one result). At the same time, labor costs for the development and implementation of such a result must be demonstrated.
- L1) The total score for a given year is limited to a maximum of 10 points for categories D, Jsc (q4) and Dsc (q4) for one co-author.
- L2) Publications will be scored only if they are in the ISI WOK or SCOPUS database in the field listed in the list annexed to these criteria. Cases in which the publication falls both thematically and content into these



fields but is in a periodical that is not in these fields will be assessed individually by the Vice-Dean for R&D.

Explanation: This is recorded in the Conference Proceedings Citation Index - Science or Social Science & Humanities, or in a journal contained in the JCR (Journal Citation Report). The citation must be linked to the quoted article in the database. Applicants submit a list of citations from the WoS database with their publication data for review. Scientists with an h-index greater than 10 are not included. The maximum number of points is 20. The citation is divided by the number of co-authors of the cited article.

Explanation: Every result of FIM UHK, which will be chosen by the UHK management for evaluation within the		
Pillars II, will receive a 20% bonus to the value of the relevant result. Upon acceptance of an excellent result by		
the Government Council in the RIV assessment, additional 100% points will be paid (recalculated to finance).

Explanation: G1) The principal grant investigator submits a proposal for the distribution of remuneration among the team members involved in its submission.

Execution instructions:

- These points are maximum and are reduced according to the scope of co-authorship in the following form:
 - By the entire share of the co-author if the affiliation in the Czech Republic.
 - If the author has more Czech affiliations, his/her share is divided by the number of his/her affiliations.
 - If there are more foreign affiliations with the author, his/her share is divided by the number of his/her affiliations without the first foreign affiliation.
 - If there is only one FIM UHK affiliates with less than 100% working load at UHK and foreign authors are co-authors, the point gain is reduced by the whole share of each foreign author.
 - If at least one FIM UHK affiliates with 100% working load at FIM UHK is involved and foreign authors are co-authors, no foreign author shall reduce the point gain.
 - Unclear cases should be consulted in advance with the Vice-Dean for R&D of FIM UHK.
- Translation is not scored. The translation can be financially remunerated up to CZK 300 /1800 characters based on the recommendation of the Head of the Department of Applied Linguistics.
- For the purposes of this evaluation, a year means the period from 1 November of the previous year to 31 October of the current year.
- The publication activity is evaluated on the basis of records registered in the school information system (in the Central Database of the OBD Pro application).
- The Vice-Dean for R&D, together with the head of the relevant department, will evaluate each member of the department on the basis of a record from the information system dated 31 October by 15 November at the latest and will submit the processed proposal for the whole faculty to the Dean of FIM, who will decide on the allocation of bonuses.
