FF UHK Dean's Decree No. 9/2019

Extraordinary Scholarships Granted on the basis of the Dean's Decision

I. General Conditions for Granting the Scholarship

1. Extraordinary scholarships granted on the basis of the dean's decision in study programmes accredited in a foreign language (scholarship) are intended for students in bachelor's and subsequent master's degree fields of study and they are available only to students who start studying these fields of study in September of the academic year 2019/2020.

II. Conditions for Granting the Scholarship on the basis of the Dean's Decision

- 1. The scholarship is granted to students of bachelor's and subsequent master's degree study programmes only in the standard study period, i.e. in the first six semesters of the bachelor's degree study and in the first four semesters of the subsequent master's degree study, and only for semesters in which they attend classes at FF UHK.
 The student is informed about the granting of the scholarship by the International Office of FF UHK in written or electronic form.
- 2. The procedure of deciding about the granting of the scholarship:
 - a) The student has sent complete materials for the admission procedure into bachelor's and subsequent master's degree programmes/fields of study according to the Decree of the Dean No. 22/2018 and the Decree of the Rector No. 18/2018 by 28. 2. 2019 to the address: marketa.machacova@uhk.cz
 - b) The admission committee of the individual fields of study draws up a recommended order of the individual applicants in the given field of study on the basis of the quality of the received applications.
 - c) On the basis of the recommendations of the admission committees, the Dean of FF UHK shall decide about the granting of the individual scholarships.
 - d) In case the student to whom the scholarship has been granted does not sign up for study, his/her claim for the scholarship expires.

3. With the acceptance of the extraordinary scholarship on the basis of the dean's decision, the student surrenders the claim for the extraordinary scholarship for excellent study results and the merit scholarship granted according to the Scholarship Code of UHK.

III. Character and Height of the Scholarship

1. The height of the scholarship is determined at 3,000 EUR for an academic year in each year of the full-time study, which means the total amount of 9,000 EUR for the bachelor's degree study and the total amount of 6,000 EUR for the subsequent master's degree study programmes.

IV. Administration of the Granting of the Scholarship

- 1. The scholarship is paid at the beginning of each semester (each time 1,500 EUR) to the student's bank account in CZK the number of which will be mentioned in the Agreement about the Granting of the Scholarship.
- 2. The scholarship will be paid in CZK depending on the up-to-date exchange rate.

V. Final Provisions

This decree takes force and effect on 25th February 2019.
